Montana Endowment Tax Credit

How The Montana Endowment Tax Credit (METC) Works

The Montana Endowment Tax Credit allows donors to pay less in Montana state income taxes when they give a qualifying **planned gift** to a Montana permanent endowment. The incentive is 40 percent of the gift's federal charitable deduction, up to a maximum \$15,000 tax credit (\$30,000 for couples), per year, per individual. Businesses can also make a direct gift to a permanent endowment and receive a credit of 20 percent of the gift amount, up to a maximum of \$15,000 per year. **This is a dollar-for-dollar tax credit**.

What Is A Qualified Planned or Deferred Gift?

A planned or deferred gift is the charitable "giving vehicle" for an individual or business to make a contribution to a qualified endowment. This gift could provide a continuous income for the donor while providing steady funds to support the Missoula Community Foundation and the work of Missoula area nonprofits.

Most common Montana planned gift:

• Charitable Gift Annuity

Other planned gifts can include:

- Charitable Remainder or Lead Trusts
- Paid-up Life Insurance Policies
- Retained Life Estates

*The amount of the Federal Charitable Deduction is reduced by the amount of the Montana Endowment Tax Credit per IRS regulation TD 9864.
